DEFINING YOUR LEGACY

BENEFICIARY DESIGNATION

Mesa Arts Center Foundation can be made a beneficiary of your life insurance policy, or through a charitable beneficiary transfer, the remaining balances in a checking or savings account, CD or brokerage account.

REQUIRED MINIMUM DISTRIBUTION (RMD)

The required minimum amount you must withdraw from your IRA or other retirement accounts each year when you reach age 70 1/2. If this money is given to a non-profit like Mesa Arts Center Foundation, through a **Qualified Charitable Deduction (QCD)** it is not taxed and you can make a charitable gift of up to \$100,000.

CHARITABLE REMAINDER TRUST (CRT)

This irrevocable trust generates a potential income stream for you, as the donor to the CRT, or other beneficiaries, with the remainder of the donated assets going to your favorite charity or charities.

CHARITABLE GIFT ANNUITY

This gift vehicle falls in the category of planned giving. It involves a contract between a donor and MACF, whereby the donor transfers cash or property to MACF in exchange for a partial tax deduction and a lifetime stream of annual income from Mesa Arts Center Foundation.
